Natural Gas Appliance INCENTIVES



Incentives are granted to new and existing Ohio Valley Gas residential, small commercial customers and developers who: convert from another fuel source to natural gas; install an eligible natural gas appliance(s) in new home construction, or replace an existing natural gas appliance with one having a higher efficiency or energy factor as set forth below.

Incentive applications are available through any OVG district office or online at ovgc.com. Navigate to the "Information" tab and select "Incentive/Rebate Information." Incentive money may be reserved for up to 60 days by completing an application. After 60 days or the end of the program year, unprocessed incentives expire. OVG does need to physically confirm the installation in order to verify eligible incentives. A copy of the receipt or invoice for the purchase of the appliance, and/or the installation of piping must be provided to process the application.
